On December 30, 1972, perforated 2111-2117' and 2124-44' with 1 JSPP. Spotted 500 gallons of 15% HCl and displaced. Breakdown pressure 1550 psi. Sand-water fraced December 31, 1972 with 35,000 gallons treated water (1% KCl and 10 pounds Gel per 1000 gallons), 5,000 pounds 20-40, 20,000 pounds 10-20, and 10,000 pounds 8-12 sand. Treating pressures: Minimum 1700 psi, maximum 2000 psi, average 1800 psi. AIR 50 BPM.
