2-11-73 TD 2898'. Ran 98 joints 2 7/8", 6.4#, J-55 production casing, 2889' set at 2898'. Baffle set at 2888'. Cemented with 463 cu.ft. cement. WOC 18 hours. Top of cement at 1325'.

5-9-73 PBTD 2888'. Tested casing to 4000#-OK. Perf'd 2860-2880' with 30 shots per zone. Frac'd with 24,000# 10/20 sand and 24,000 gallons treated water. No balls dropped. Flushed with 1000 gallons water.
