Perforated 4920-24, 4992-94, 4998-4103, 4124-90, 4198-4237, 4358-62, 4394-4418, 4438-44, 4454-58, 4497-4525, 4537-40, 4562-68, 4644-60, 4704-08, 4738-4804, 4808-4824. Sand-water fraced in three intervals with 337,040 lbs. sand and 185,400 gallons frac fluid consisting of 17 KCL water, 1 lb. surfactant and 20 lbs. gel per 1000 gallons water. Production tubing landed at 4812'.

Instructions

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
