Perforated 4068-74, 4144-50, 4208-14, 4234-40, 4249-70, 4274-4304, 4420-26, 4436-40, 4448-60, 4463-68, 4488-4500, 4505-08, 4511-16, 4545-30, 4695-4703, 4736-66, 4772-4826, 4831-41, 4850-58. Sand water hydrafrac in three stages with a total of 249,560 lbs sand and 137,280 gal frac fluid at 2#/gal. The frac fluid contained 1% KCL, 20% Gal, and 1 gallon surfactant per 1000 gallon water. Ran 2-3/8" tubing and cleaned out sand to a plug back depth of 4945'. Tubing set at 4842'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
