Completion operation commenced on 12/15/77. Ran 2-3/8" tubing and cleaned out to PBD of 4853'. Pressure tested casing to 3000# for 15 minutes; held OK. Perforated 3945-48, 3980-83, 3986-91, 4056-60, 4063-69, 4098-4102, 4126-30, 4140-46, 4283-86, 4290-97, 4302-05, 4314-21, 4455-61, 4528-32, 4634-38, 4655-78, 4682-4706, 4716-20, 4736-39. Sand-water fraced in three intervals with a total of 250,040# sand and 137,500 gallons frac fluid consisting of 1% KCL, 1 gallon surfactant and 20# gel per 1000 gallons water. Production tubing landed at 4732'.

Instructions
