Cemented w/700 Sx 50/50 poz mix, 4% Gel, 6 $\frac{1}{4}$ # Sx Gilsonite, $\frac{1}{4}$ # Sx Flocele, .2% CFR-2, followed by 100 Sx class "B" cement. Circulated to surface. WOC 12 hrs. Released rig. WOCU

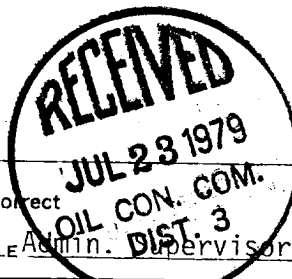
