Circulated to surface. WOC 12 hrs. Reduced hole to 7 7/8" & drilled to T.D. @ 3051' on 7/12/79. Ran electric logs. Ran 93 jts 4 $\frac{1}{2}$ ", 10.5#, K-55 csg & set @ 3015'. Cemented w/700 Sx class "B" 50/50 poz mix, 4% Gel, 6 $\frac{1}{4}$ # Sx Gilsonite, $\frac{1}{4}$ # Sx Flocele, followed by 100 Sx class "B" neat cement. WOC 12 hrs. Released rig. WOCU. Ran electric logs from PBTD to surface.
