It is intended to repair a casing leak in the following manner:  
Set a retrievable bridge plug above the Mesa Verde perforations.  
Locate hole in casing with a packer.  
Run cement retainer set above casing leak and squeeze with cement.  
Drill out cement, retrieve bridge plug and return well to production.
