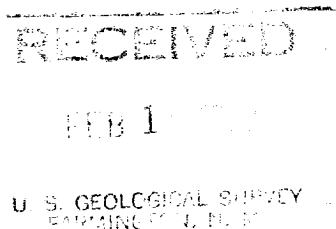

This well has been temporarily abandoned in the following manner:

Cut stuck tubing at 5572', pulled in two at 3300', found free point and cut tubing at 5520', pulled tubing, left 628' fish in open hole.

Set cement retainer at 5290', squeezed open hole w/250 sacks cement. Located holes in 7" casing (2233 - 2530'). Set cement retainer @ 2050', squeezed holes in 7" casg. w/150 sacks cement, squeezed to 1300#.

Laid down tubing, left wellhead and xmas tree in place.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
