(4 stages)
5-20-57. B.P. at 5260'. Perf. w/2 DJ/ft. Int. 5075-5108. Water frac Cliff House w/55,500 gal. water, 60,000# sand. Flush 5400 gal. water. Injection rate 55.3 BPM. Breakdown pressure 1700#, average treating pressure 1800#, maximum treating pressure 2250#.

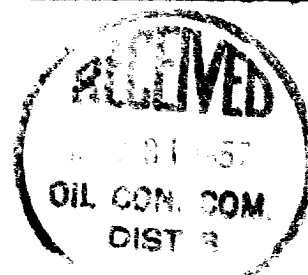
