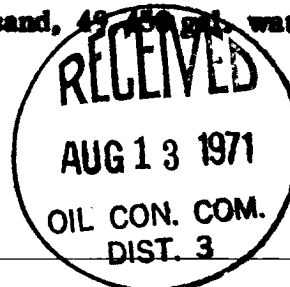

7-23-71 Cut off stuck tubing at 5100' and pulled tubing.

7-24-71 Set cement retainer at 4871', tested casing to 1000 psi O. K. Squeezed open hole w/150 sacks of cement. Perforated squeeze hole at 2423', set cement retainer at 2316', squeezed through perf. w/125 sacks of cement.

7-28-71 Sidetrack T. D. 5809'. Ran 188 joints 4 1/2", 10.5#, K-55 production casing (5797') set at 5809' w/125 sacks of cement. W.O.C. 18 hours.

7-29-71 P.B.T.D. 5793', perf. 5442-54', 5478-84', 5543-49', 5559-65', 5706-12, 5739-45' w/18 SPZ. Frac w/49,000# 20/40 sand, 40,300 gal. water, dropped 5 sets of 18 balls, flushed w/4440 gal. water. Tested baffle at 5389' w/3500# O. K. Perf. 5065-71', 5084-96', 5134-46', 5168-80', 5260-70', 5328-38' w/18 SPZ. Frac w/49,000# 20/40 sand, 49,450 gal. water, dropped 5 sets of 18 balls, flushed w/3570 gal. water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for special instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
