7" at 5059' with 300 sacks regular cement.

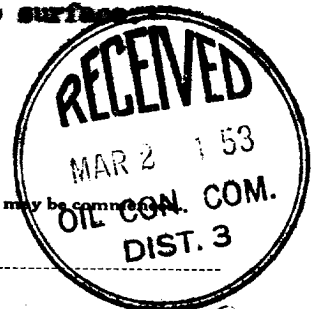
