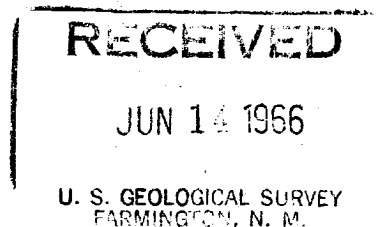
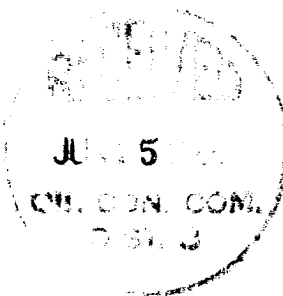

Pull 2-3/8" tubing, clean out to 6720', run 4-1/2" - 10.50# J casing from surface to TD; circulate cement, perforate and sand-water fracture the Mesaverde Zone in two stages, rerun 2-3/8" tubing and return well to production.
