On 8-8-70 Cut stuck tubing off at 5205', pulled tubing, set cement retainer in 7" at 4994', squeezed open hole w/150 sacks of cement.

On 8-9-70 Perf. 2 squeeze holes at 2556', set cement retainer at 2536', squeezed perfs w/50 sacks of cement.

On 8-10-70 set cement retainer at 2510', re-squeezed perfs at 2556' w/150 sacks of cement.

On 8-14-70 Total depth 6085'. Ran 187 joints 4 1/2", 10.5#, KS production casing (6075') set at 6085' w/125 sacks of cement. W.O.C. 18 hours.

On 8-15-70 P.B.T.D. 6072', perf. 5550-62', 5576-84', 5620-28', 5668-80', 5802-14', 5857-69', 5964-76' w/18 SPZ. Frac w/72,500# 20/40 sand, 72,500 gal. water, dropped 6 sets of 18 balls, pumped bridging ball to baffle at 5452', tested to 3000# O. K.

Perf. 5244-52', 5262-70' w/18 SPZ. Frac w/30,000# 20/40 sand, 30,000 gal. water, dropped 1 set of 18 balls, flushed.

Instructions
