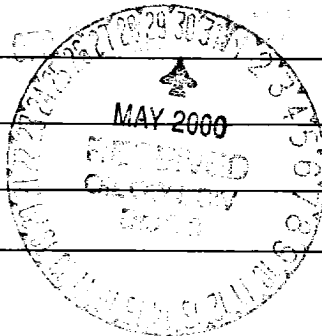

1. MIRU. Release packer and TOH.
2. Run packer and hydrotest tubing in hole. Set packer at 3500'.
3. Test casing to 500 psi. If test holds, return to long term shut-in. If test fails, a plug and abandonment procedure will be filed.
