Dear Sir:

On November 16, 1951 a Notice of Intention to Drill was filed on Blackwood & Nichols #1-E Alsup, Section 14-30N-4W. Our scout has learned that this well was drilled to T.D. 3960' in the Fictured Cliffs Sandstone and was temporarily abandoned on 4-22-52.

According to the Rules and Regulations of the Oil Conservation Commission, all operations performed on any well drilled on State or patented land in the state must be reported to the District Office on Form C-103, "Miscellaneous Reports on Wells." A Form-C-103 should have been submitted showing where surface pipe was set and how cemented and what shoe tests were made, and the same information should have been reported on the production casing. Also, after the well was completed a Well Log, Form C-105, should have been submitted to the Commission showing what the drilling results were and the status of the well as it was left.

We are enclosing a sufficient number of Form C-103 for you to make the above reports and also Form C-105 so that you may submit a Well Log.
