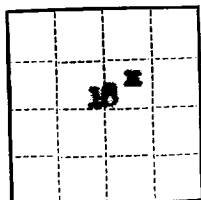

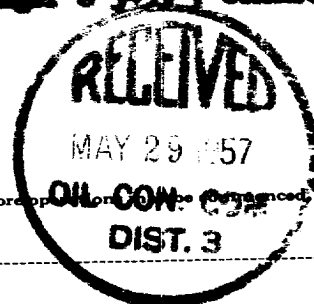
DETAILS OF WORK

Set 3540.70' of 7-5/8" casing @ 3552', cemented w/150 sz 8% gel and 50 sz ment. Casing tested ok.

Set 2341.59' of 5-1/2" liner @ 5800', Bash Ross Liner Hanger @ 3450', cemented w/200 sz rag. Press to 2000#, held ok.
