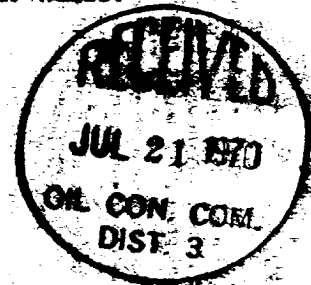

On 6-29-70 cut stuck tubing off at 5085', pulled 167 joints tubing. Set cement retainer at 4825'.

On 6-30-70 squeezed open hole w/100 sacks of cement. Perforated 2 holes at 2313', set cement retainer at 2268', squeezed through perms w/250 sacks of cement.

On 7-4-70 T.D. 5863'. Ran 178 joints 4 1/2", 10.5#, K-55 casing (5851') set at 5863' w/125 sacks of cement. W.O.C. 15 hours.

On 7-5-70 P.B.T.D. 5831'. Perf. 5424-36', 5450-62', 5494-5506', 5550-62', 5692-98', 5746-52', 5898-5804' w/18 KX SPZ. Frac w/64,000# 20/40 sand, 51,260 gal. water, dropped 6 sets of 18 balls, flushed w/3880 gal. water. Pumped bridging ball to baffle at 5344', tested to 3000# O. K. Perf. 5090-5102', 5126-38', 5236-48', 5284-96' w/18 SPZ. Frac w/40,000# 20/40 sand, 35,580 gal. water, dropped 3 sets of 18 balls, flushed w/3550 gal. water.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
