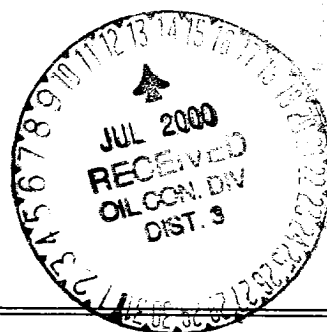

2. TIH with RBP and packer. Test and isolate suspected leak.
3. Squeeze cement leak with a sufficient amount of cement to repair leak.
4. Drill out cement, rerun tubing and return to production.
