DETAILS OF WORK

Run 2-3/8" tubing, clean out with gas to approximately 5530', run approximately 800' of 5/8" liner (with turned down collars), and cement with 350 sacks cement.

Selectively perforate the Mesaverte Group and sand-water free in two stages with 50,000 gallons of water and 50,000 lbs. of sand per stage.

Rerun tubing and repotential.
