DETAILS OF WORK

It is intended to drill a well with rotary tools thru the Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs and set intermediate casing. Gas circulation will be used thru the Mesa Verde and production liner will be set. Possible productive intervals will be perforated and fractured. Estimated Total Depth 5700'.

Casing Program:

9 5/8" set at 230' with 200 sacks cement circulated to surface.  
 7" set at 3480' with 150 sacks cement - 150% to cover Ojo Alamo.  
 4 1/2" set at 5700' with 270 sacks cement - 200% to fill to liner top.

The E/2 of Section 8 is dedicated to this well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

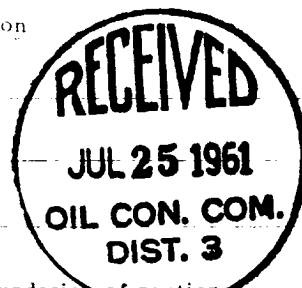

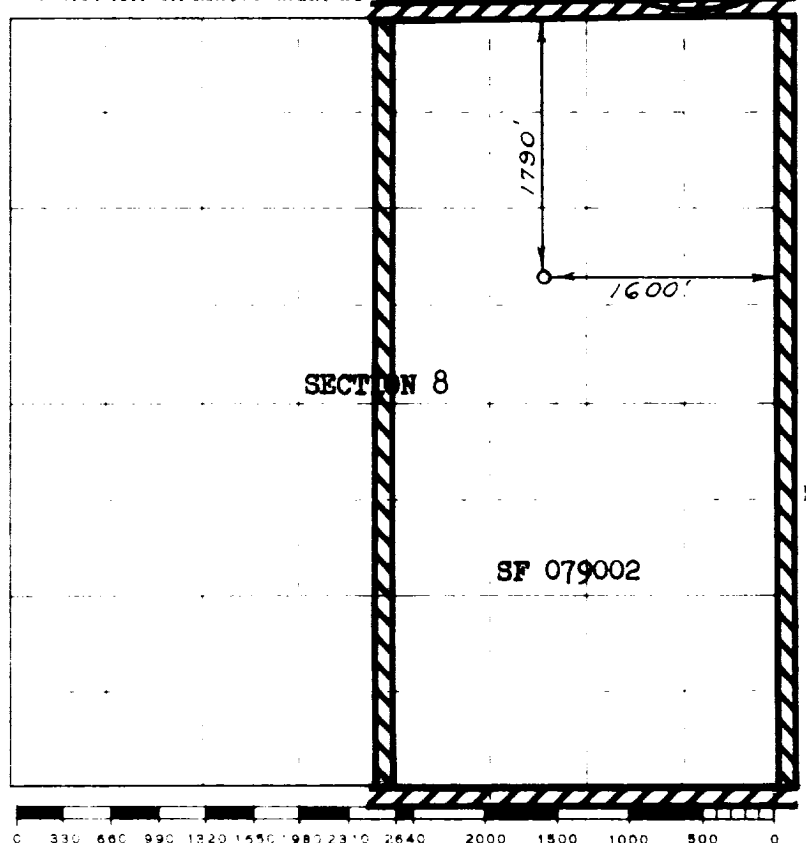
