5 1/2" liner at 5710' with 300 sacks cement.

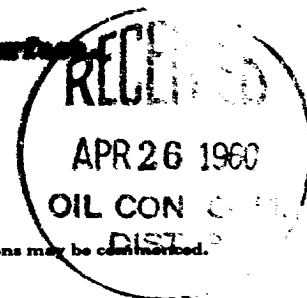

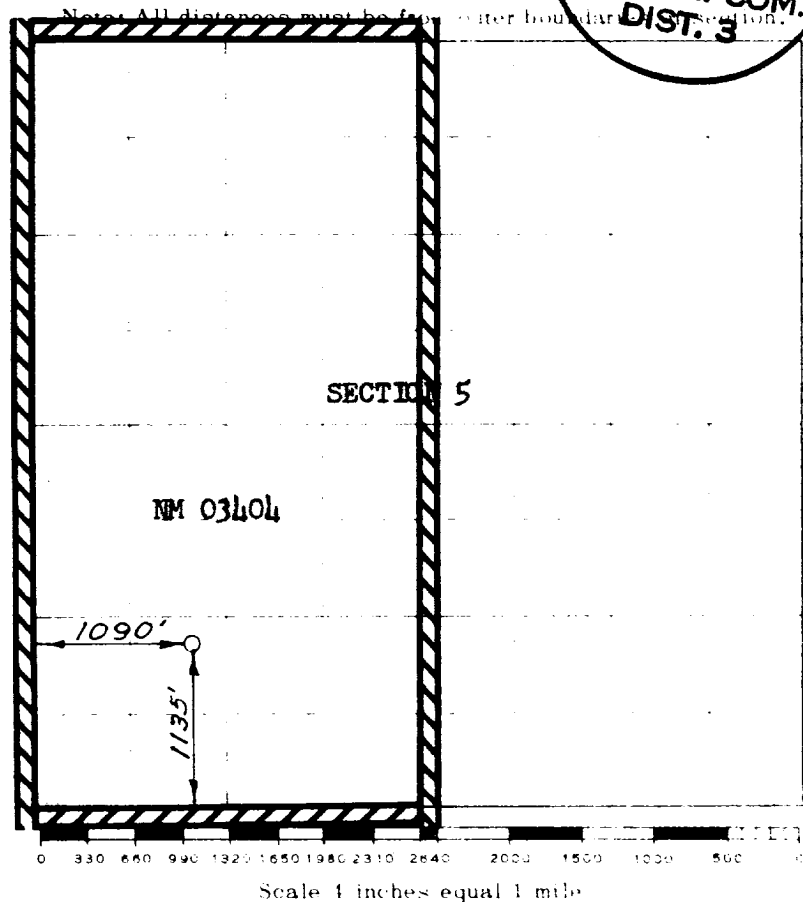
