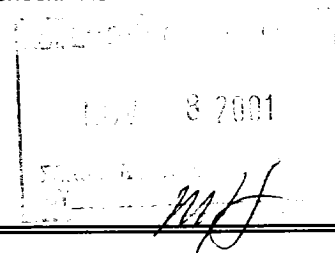

RIH w/2-3/8", 4.7# tubing and set @ 5590' w/"F" nipple set @ 5556'. ND BOP, NU WH. Pumped off expendable check. RD & released rig. Turned well back over to production.
