Detailed account of work done, nature and quantity of materials used, and results obtained.

This well was temporarily abandoned in the following manner:

Found tubing was stuck. Shot tubing off at 5337' and pulled tubing.

Set retainer in 7" casing at 5000' and squeezed w/150 sacks cement w/4% gel & 1/4 cu. ft. Gilsonite per sack, followed by 50 sacks neat cement (320 cu. ft. of slurry). Left 25' cement plug on retainer.

Tested casing w/packer and found leaks at 1484' and 315'.

Spotted 50 sacks cement 1508' to 1260' and 50 sacks at 315' to 67'. Squeezed holes by displacing cement w/7 bbls. of water. Left top of cement in casing at 175'.

Bolted a steel plate w/4' x 4" dry hole marker on surface casing flange. Work completed 10-13-64.
