w/7602 gal. water. Set bridge plug at 5400', tested to 3500# O. K. Perf. 5302-08', 5318-24',
5334-40' w/18 SPZ. Frac w/40,000# 20/40 sand, 32,422 gal. water, dropped 2 sets of 18 balls,
flushed w/7224 gal. water.

Instructions
