POOH with 2-3/8" tubing. Clean out wellbore. Run GR/CCL cased hole logs. Reperforate Mesaverde from 5722-5860' OA. Breakdown each interval with PIP tool & 15% HCl. Flowback to clean up. Set RBP. Perf Lewis Shale from 4380-4705' OA. Sand frac Lewis Shale. Flowback to clean up. Pull RBP. Run spinner survey. Rerun 2-3/8" production tubing.
