In January 1996 the Lewis Shale pay was added to the existing Mesaverde interval. A packer and a sliding sleeve in the tubing was placed across the Lewis Shale interval for testing. The packer and the sliding sleeve were removed as follows:

1/8/98

MIRU Big A #29. Closed sliding sleeve and set plug in "F" nipple. ND WH & installed BPV. NU BOPs. Unseat packer and POOH with packer and sliding sleeve. Land tubing @ 5806'. ND BOPs & NU WH. Pull BPV. PT tubing. Pump off check. RD & MO. Turned well back over to production dept.
