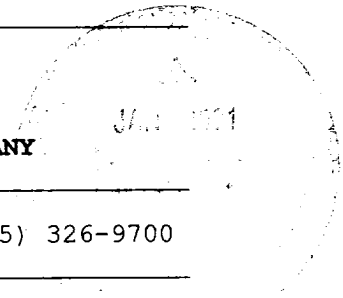

13. Describe Proposed or Completed Operations

It is intended to commingle the subject well in the Tapacito Pictured Cliffs (Pool Code 85920) and the Blanco Mesaverde (Pool Code 72319). The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the work is completed. Commingling will not reduce the value of the production.
