Dear Mr. Ramey:

This is a request for administrative approval for an unorthodox gas well location in the Blanco Mesa Verde pool.

It is intended to locate the El Paso Natural Gas Company's San Juan 30-6 Unit #58A at 800' from the North line and 1930' from the West line of Section 31, T-30-N, R-6-W, Rio Arriba County, New Mexico.

Extremely rough terrain with cliffs and ledges in the northwest corner of this section makes it impossible to build an orthodox gas well location.

All operators of proration units offsetting the proposed unorthodox location have been notified of this application by certified mail.

Plats showing the proposed well location and the terrain of Section 31, along with an ownership plat, are attached.

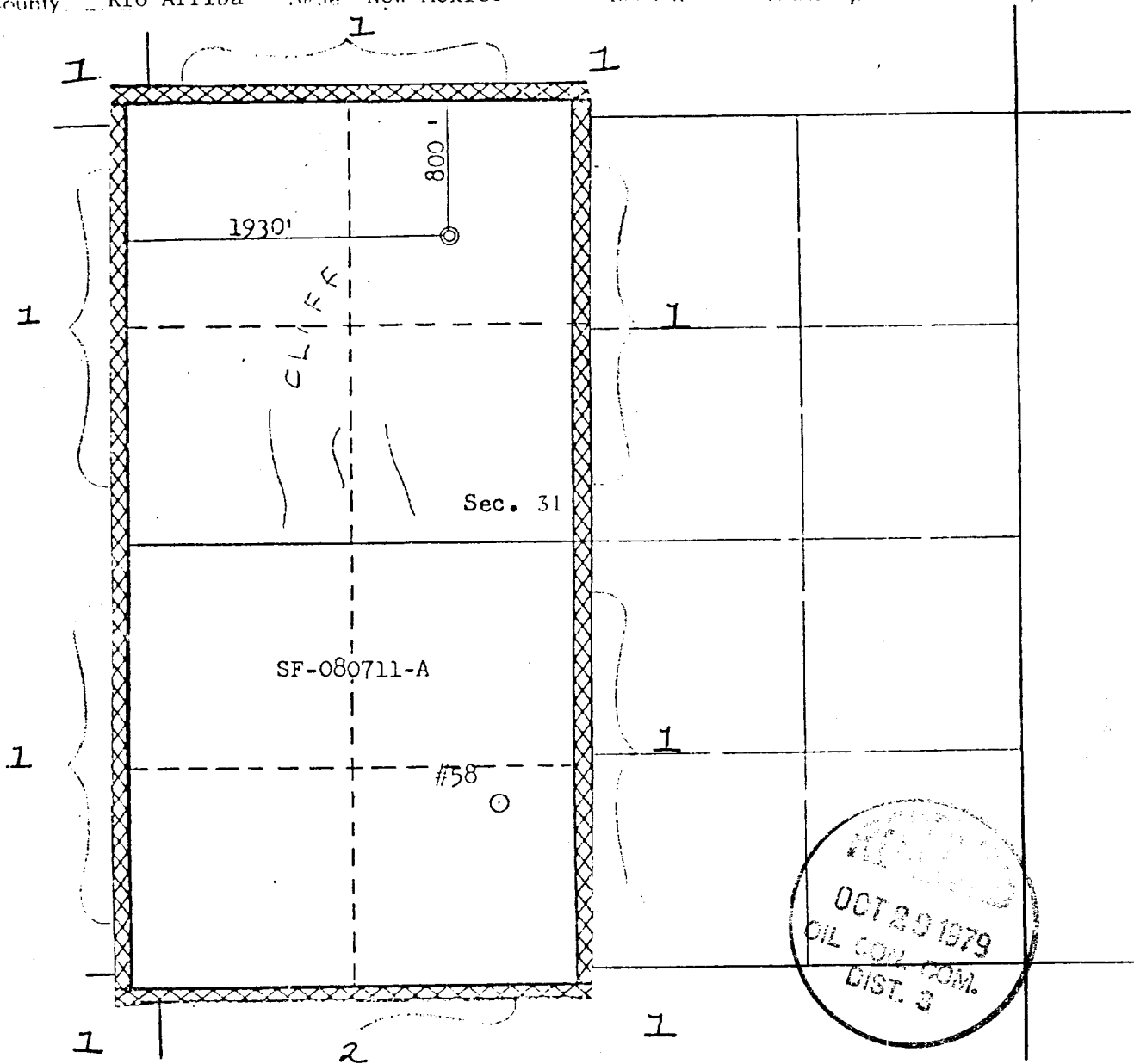

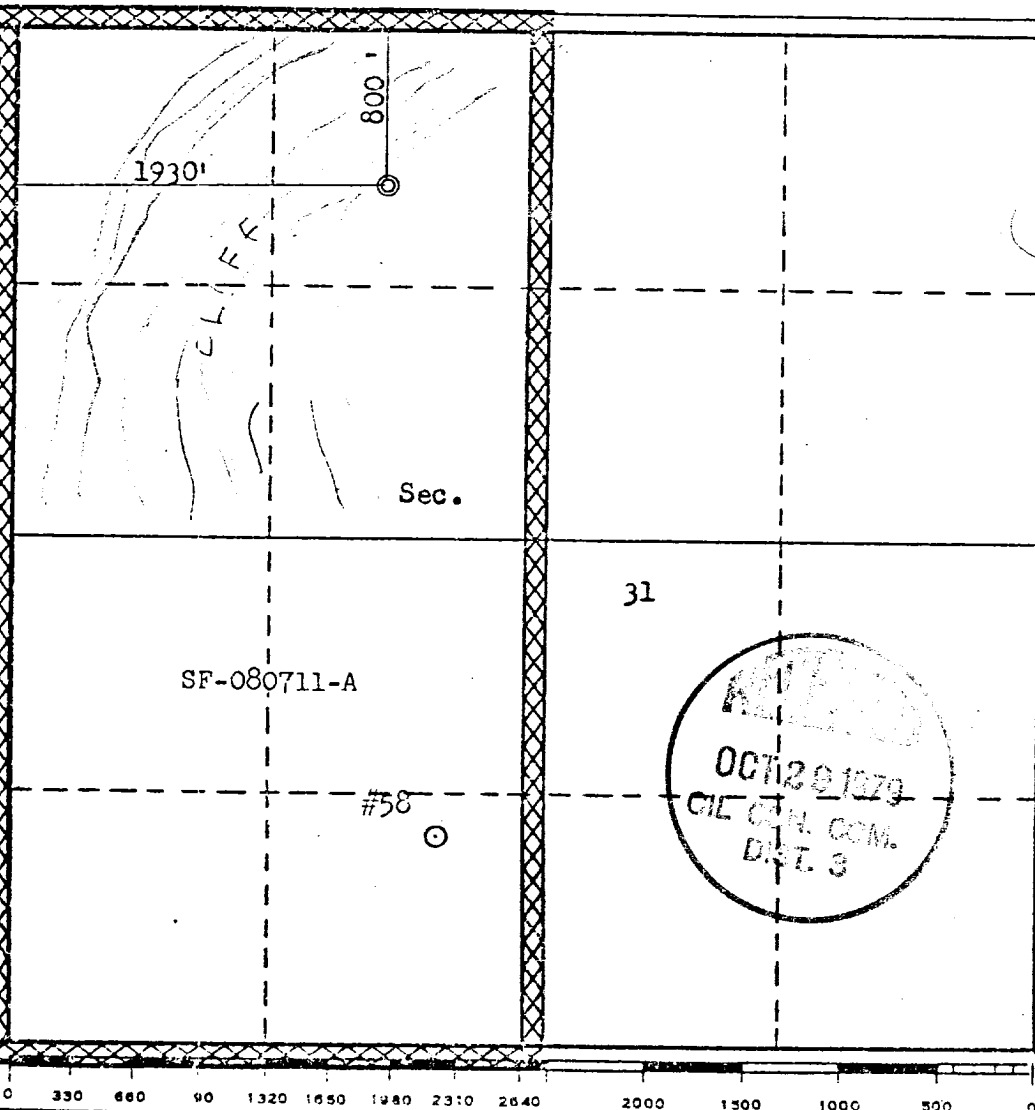
