Plans are to add the MV interval to the existing DK well and then commingle production from both zones per DHC order #11363. A sundry detailing the Dakota forecast will be filed before actual commingling occurs. A brief detail of the procedure we will be using is as follows:

MIRU. COOH w/production tubing. Isolate existing DK interval with bridge plug. PT casing and remediate with cement if casing fails pressure test. Run GR/CCL/CBL & remediate with cement if the interval completing isn't adequately covered. Perforate and stimulate the MV intervals. Remove bridge plug and return well to production with the Mesaverde and Dakota intervals commingled. May flow test the MV before commingling occurs.

A workover pit will be used during the workover and will be lined and fenced. Once the workover is completed the pit will be closed. Attached is the C102 for the Mesaverde zone.


