The plug blocking Dakota production was knocked out of the tubing and the sliding sleeve across the Mesaverde perfs was closed. The Dakota zone is now producing and the Mesaverde zone is shut-in.

Once pressures are stablized the sliding sleeve across the Mesaverde perfs will be opened and the Dakota and Mesaverde production will be commingled. A sundry will be submitted reporting the date commingling occurs.
