8-20-83 Pressure tested casing to 600 psi. Drilled 7-7/8" hole to a total depth of 4115'. Ran 93 joints (4099') of 4-1/2", 10.5#, K55 casing set at 4111'. Cemented first stage with 241 cubic feet of Class "B" containing 50/50 POZ, 6% gel, 1/4# flocele. Tail in with 129.8 cubic feet of Class "B" containing 1/4# flocele. Plug down at 10:00 am on 8-20-83. Top of cement at 3100' by temperature survey.
