Will drill 9" hole to 125' and set 125 feet 23#/ft J-55 casing cementing with 30 ft³ Class B cement, circulated to surface. Will drill 6½" hole to 4290' and run 4290' of 4½" 11.6#/ft J-55 casing and cement with 206 ft³ Class B with 2% econofil tailed by 89 ft³ 50-50 pozmix with 2% gel and 10% salt. Circulating medium will be clear water, natural mud and water loss control additives. No abnormal pressures or temperatures are anticipated. Will run Induction and Density Logs. Blowout preventer schematic is attached. The gas from this formation is not dedicated to a gas contract.


