This is a request for administrative approval for an unorthodox gas well location in the Undesignated Fruitland Pool.

It is intended to locate El Paso Natural Gas Company San Juan 30-6 Unit #418 at 450' from the North line and 1950' from the East line of Section 26, T-30-N, R-7-W, Rio Arriba County, New Mexico.

Extremely rough terrain in the form of steep cliffs makes it impossible to build an orthodox location in the northeast quarter of this section.

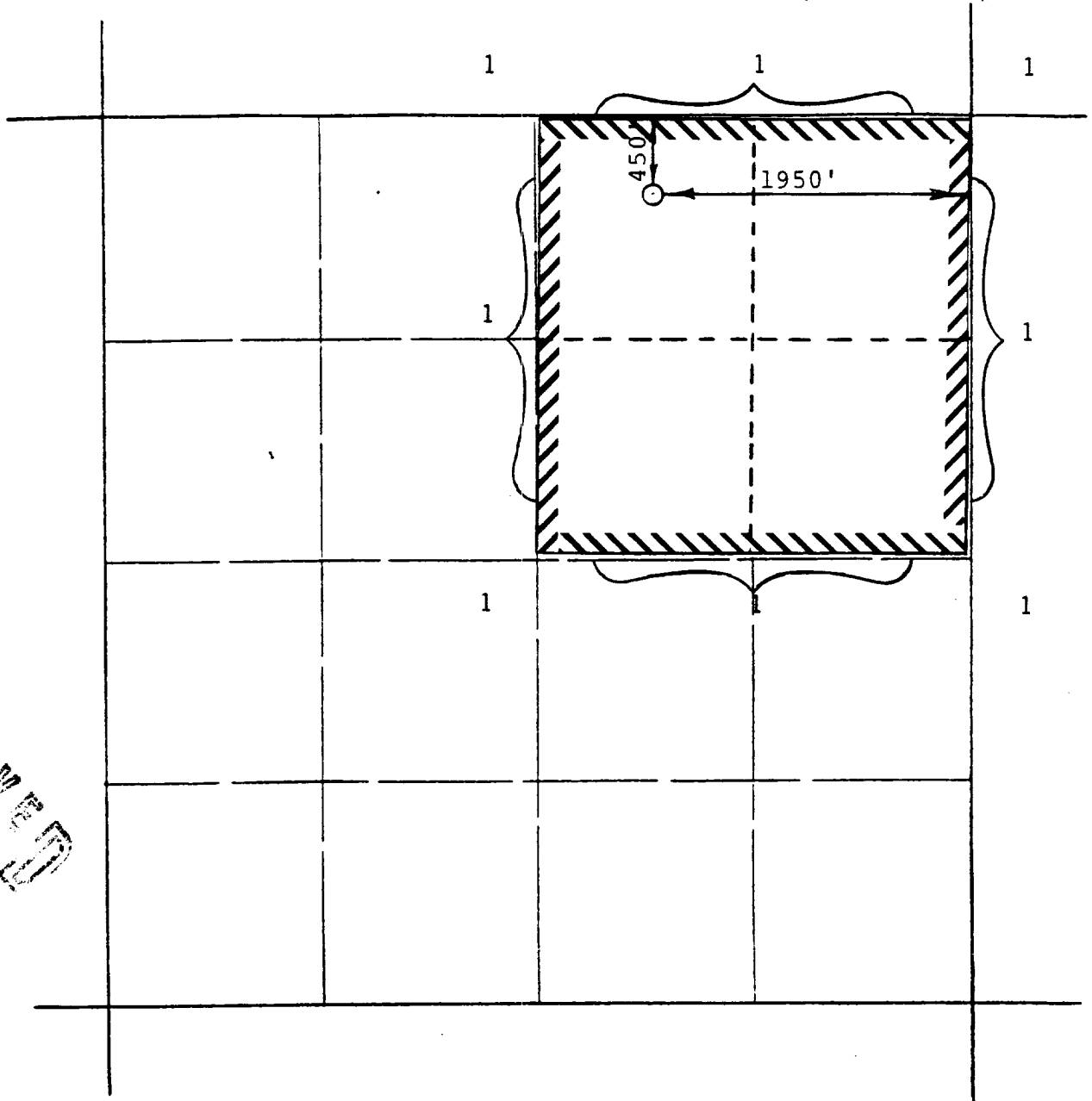

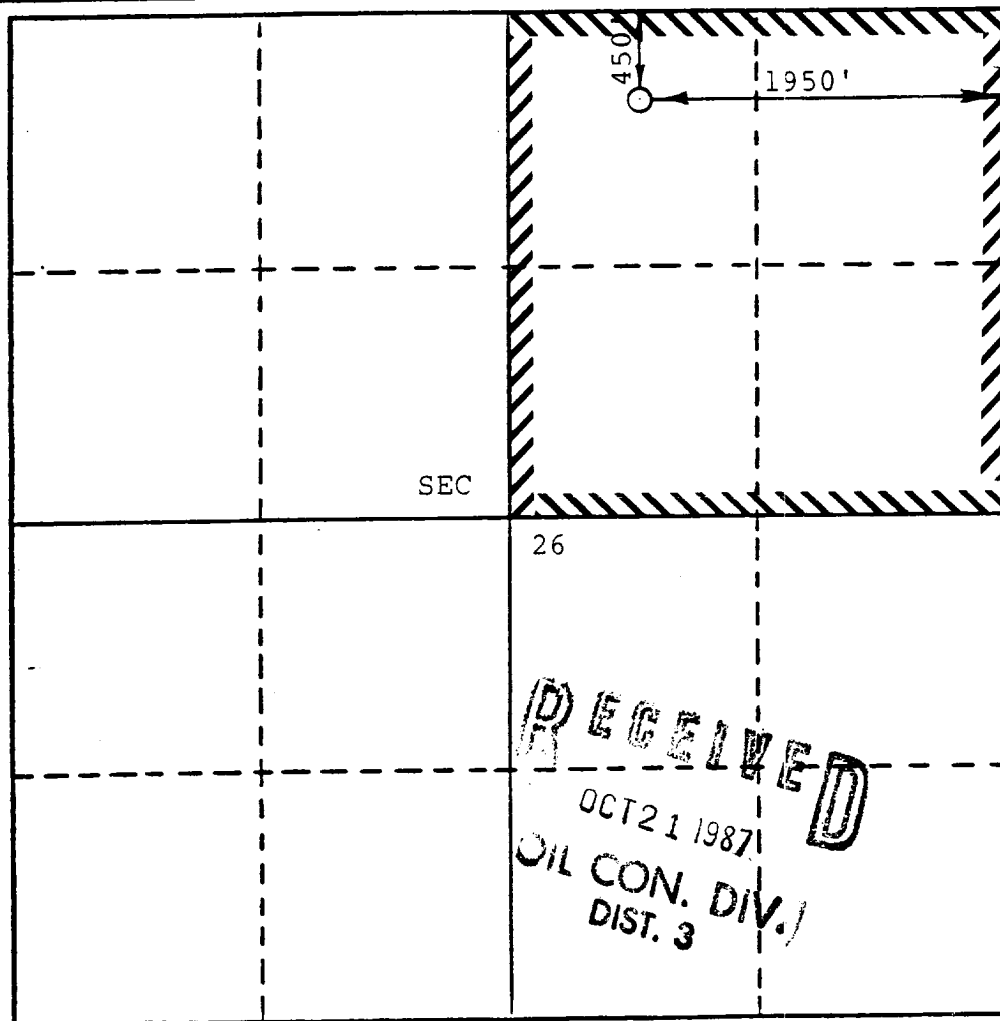
