13. Describe Proposed or Completed Operations

It is intended to workover the well in the following manner:

Pull the 2 7/8" tubing. Pull the 5 1/2" liner. Underream the well to 9 1/2". Cavitate the Fruitland Coal formation utilizing natural and air assisted surges until the well stabilizes. Clean the well to TD and run a 5 1/2", 15.5#, K-55 casing liner. The liner will be pre-perforated with 4 SPF across the coal intervals. Production tubing will be 2 7/8", 6.5#, J-55. The well will then be returned to production.
