Will drill 6-3/4" hole to 4025' and run 4025' of 4-1/2" 11.6#/ft J-55 casing and cement with 252 ft<sup>3</sup> 50/50 pozmix with 2% gel and 10% salt. Circulating medium will be clear water, natural mud and water loss control additives. No abnormal pressures or temperatures are anticipated. Will run Induction and Density Logs. Blowout preventer schematic is attached. The gas from this formation is not dedicated to a gas contract.

## INSTRUCTIONS

GENERAL: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. 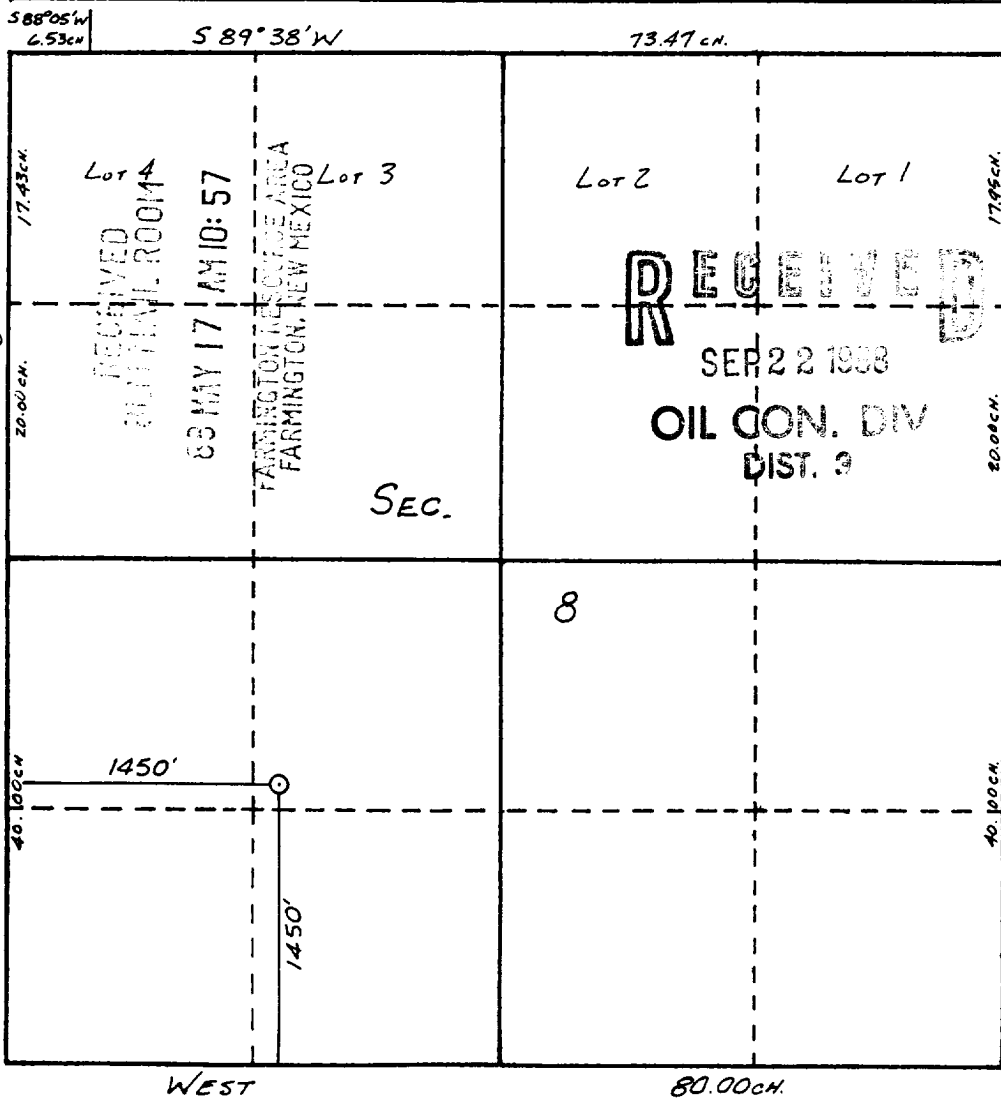

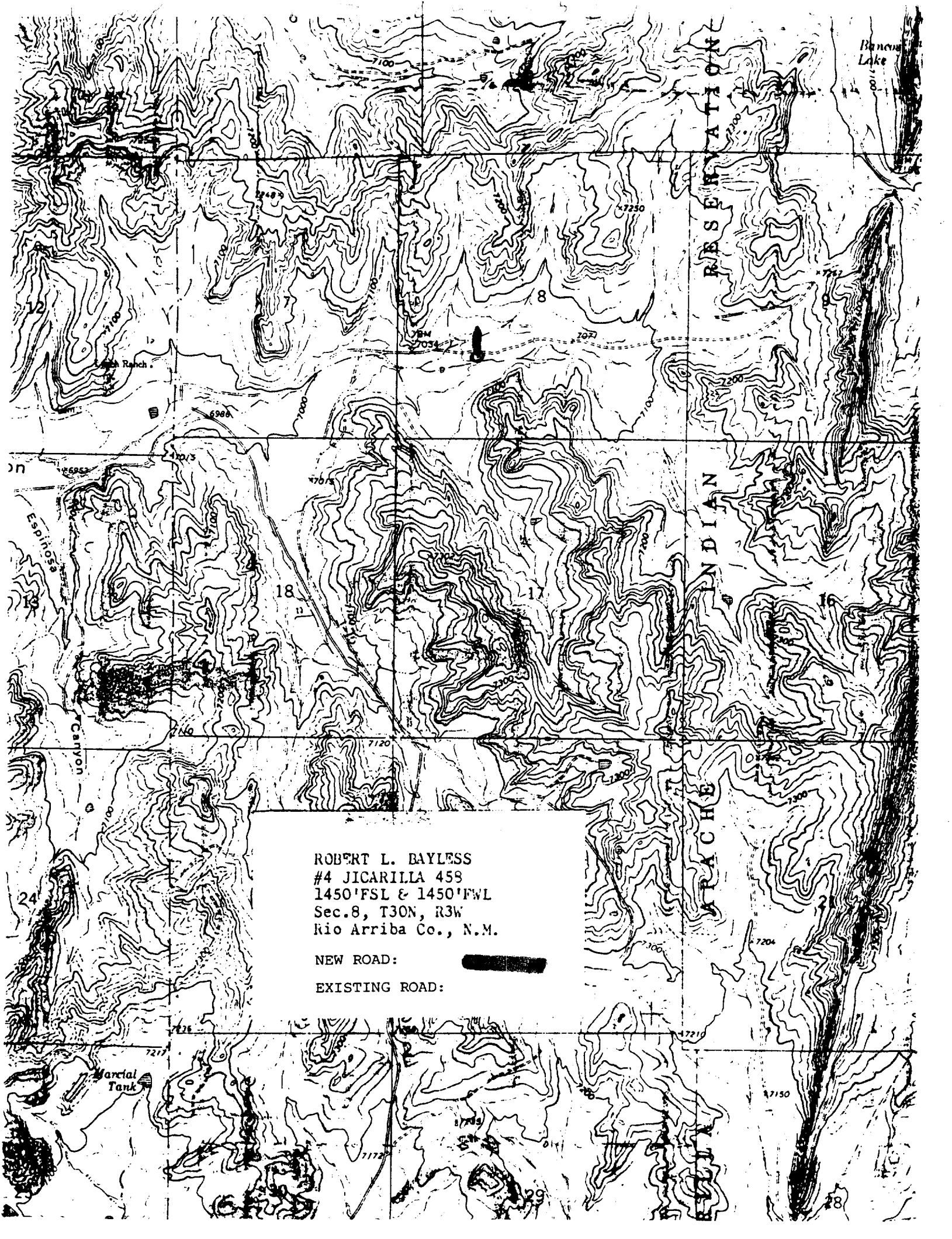
