Will drill hole to 125' and set 125 ft. of 7-5/8" 26.4#/ft J-55 casing, cementing with 71 ft³ Class B cement, circulated to surface. Will drill 6-3/4" hole to 4075' and run 4075' of 4-1/2" 11.6#/ft J-55 casing and cement with 252 ft³ 50/50 pozmix with 2% gel and 10% salt. Circulating medium will be clear water, natural mud and water loss control additives. No abnormal pressures or temperatures are anticipated. Will run Induction and Density Logs. Blowout preventer schematic is attached. The gas from this formation is not dedicated to a gas contract.

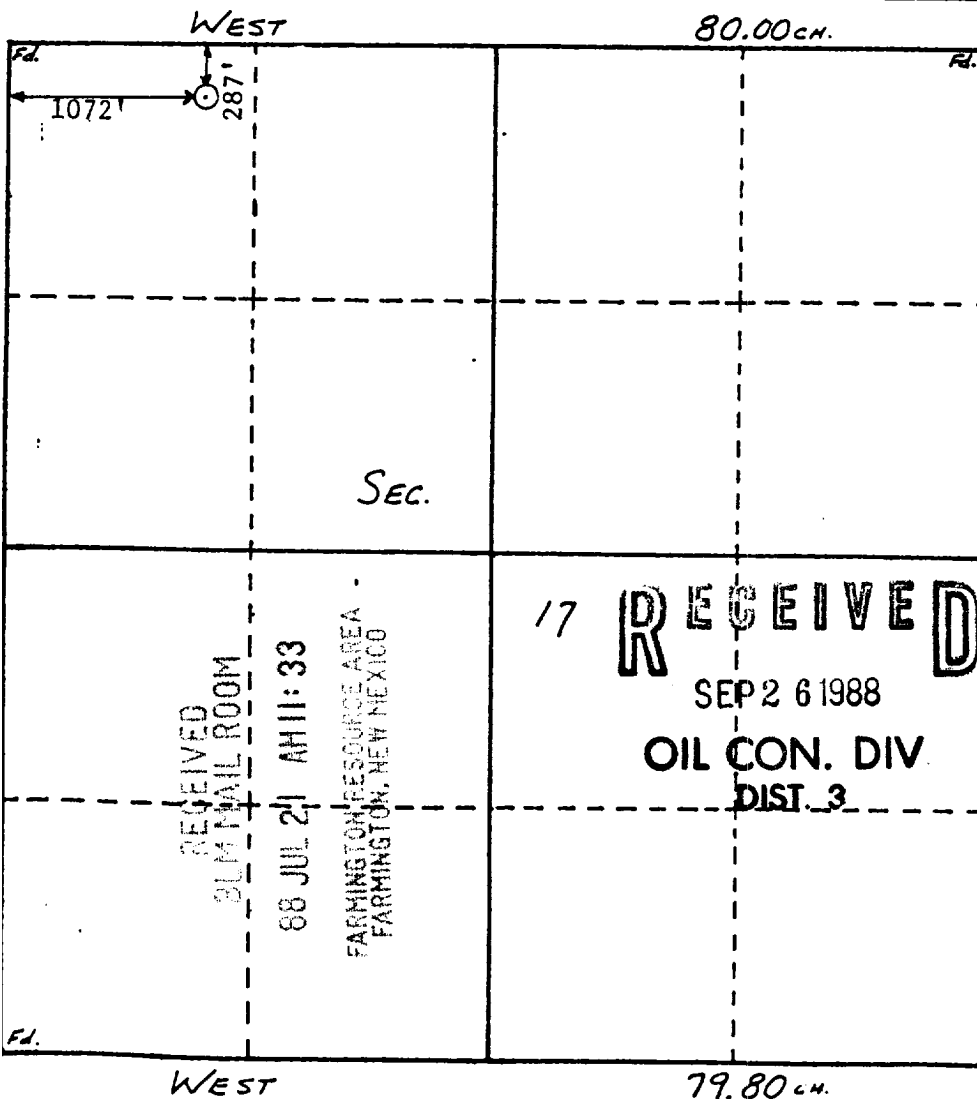

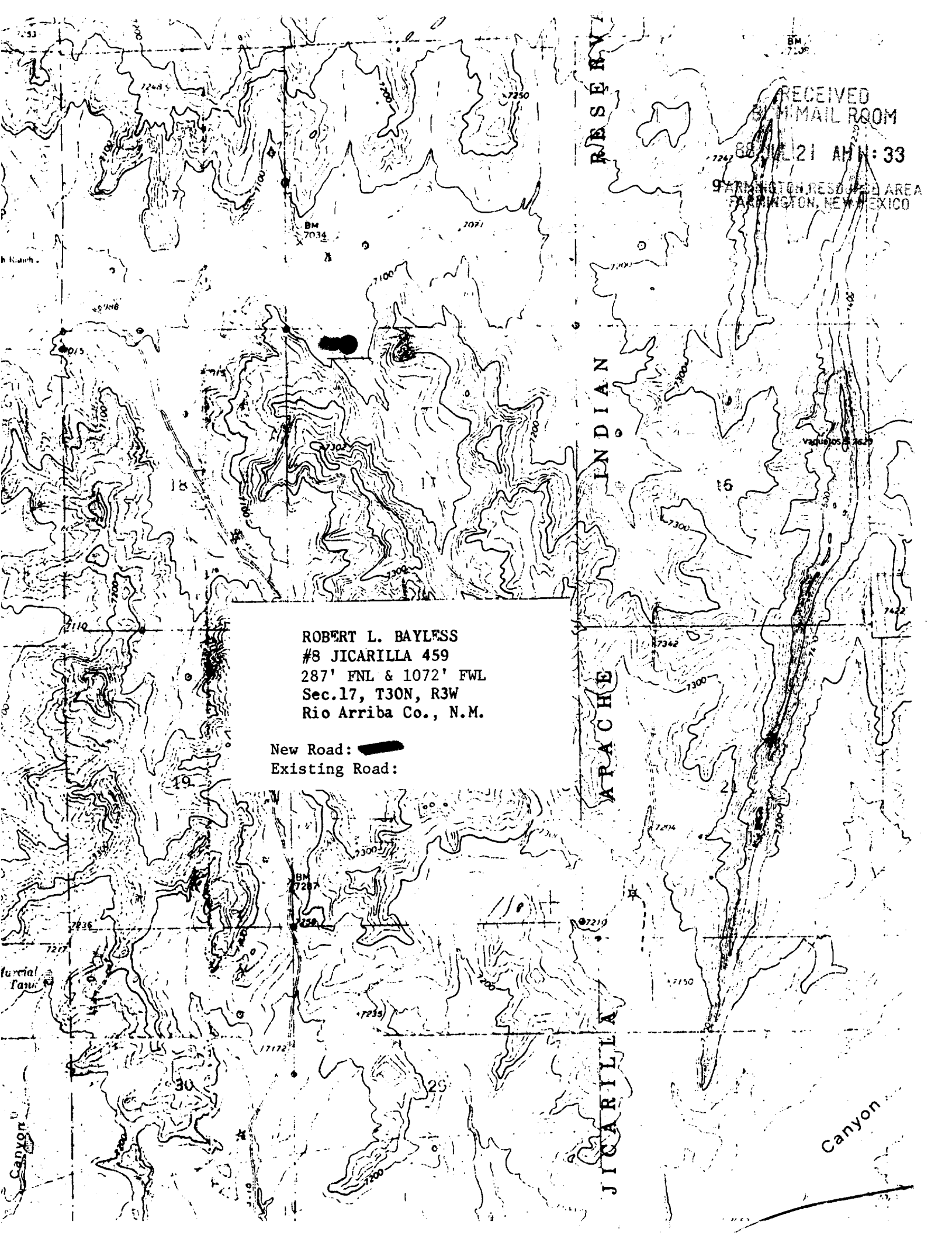



We request administrative approval of an unorthodox location for our Jicarilla 459 #8 Pictured Cliffs formation gas well, located 287' FNL & 1072' FWL, Section 17, T30N, R3W, Rio Arriba County, New Mexico. This well staking is 503 feet too close to the section line separating Section 17 and Section 8. This well staking is necessitated by the surface lessees. The Jicarilla Apache Tribe has assigned the area to the south, our orthodox location site, to Ms. Carol Collins. She has fenced in the valley to provide controlled pasture and has requested that we build the location outside this pasture.

Please note from the enclosed lease map that Robert L. Bayless is the operator of all surrounding 160 acre tracts to this well. If you need further information on this matter, please advise.

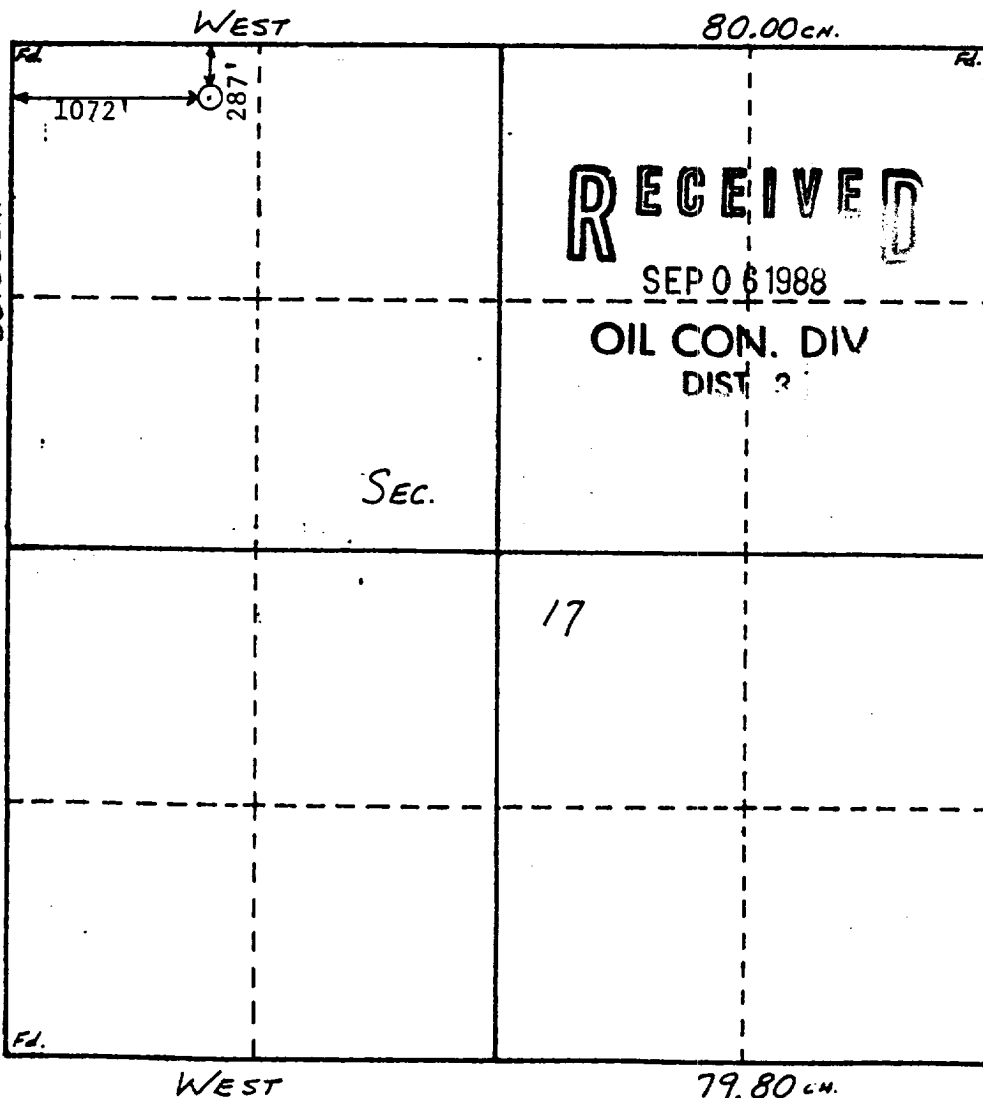
