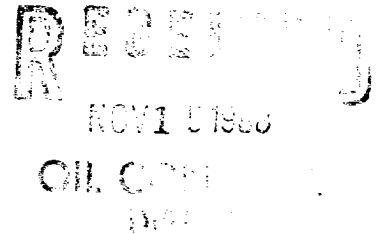

Dear Mr. Clark:

Reference is made to your application of October 31, 1988 for a non-standard coal gas well location for your Northeast Blanco Unit Well No. 431 to be located 795 feet from the South line and 1825 feet from the East line (Unit O) of Section 17, Township 30 North, Range 7 West, NMPM, Basin Fruitland Coal Gas Pool, Rio Arriba County, New Mexico. The S/2 of said Section 17 shall be dedicated to the well forming a standard 320-acre, more or less, gas spacing and proration unit.



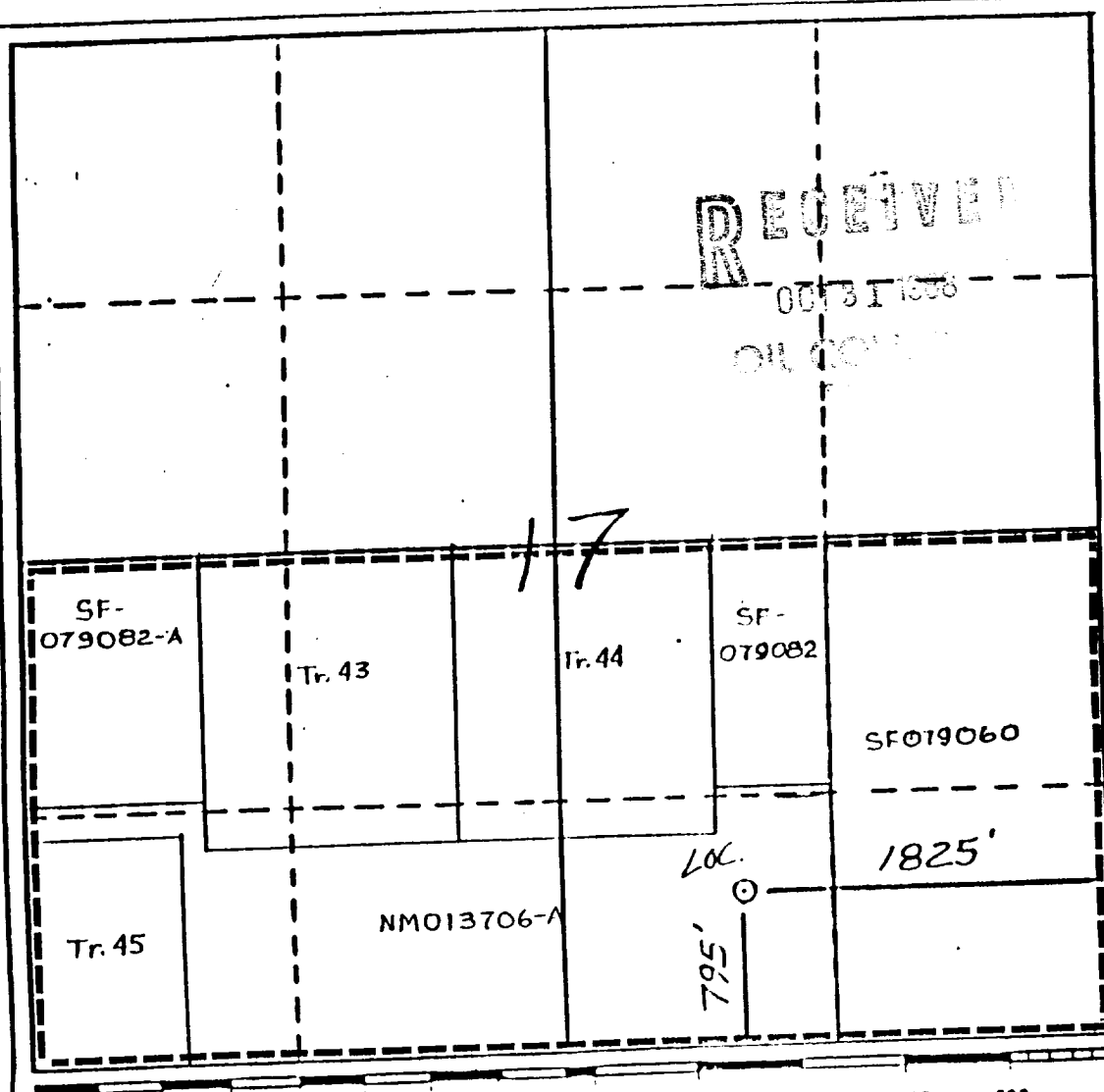

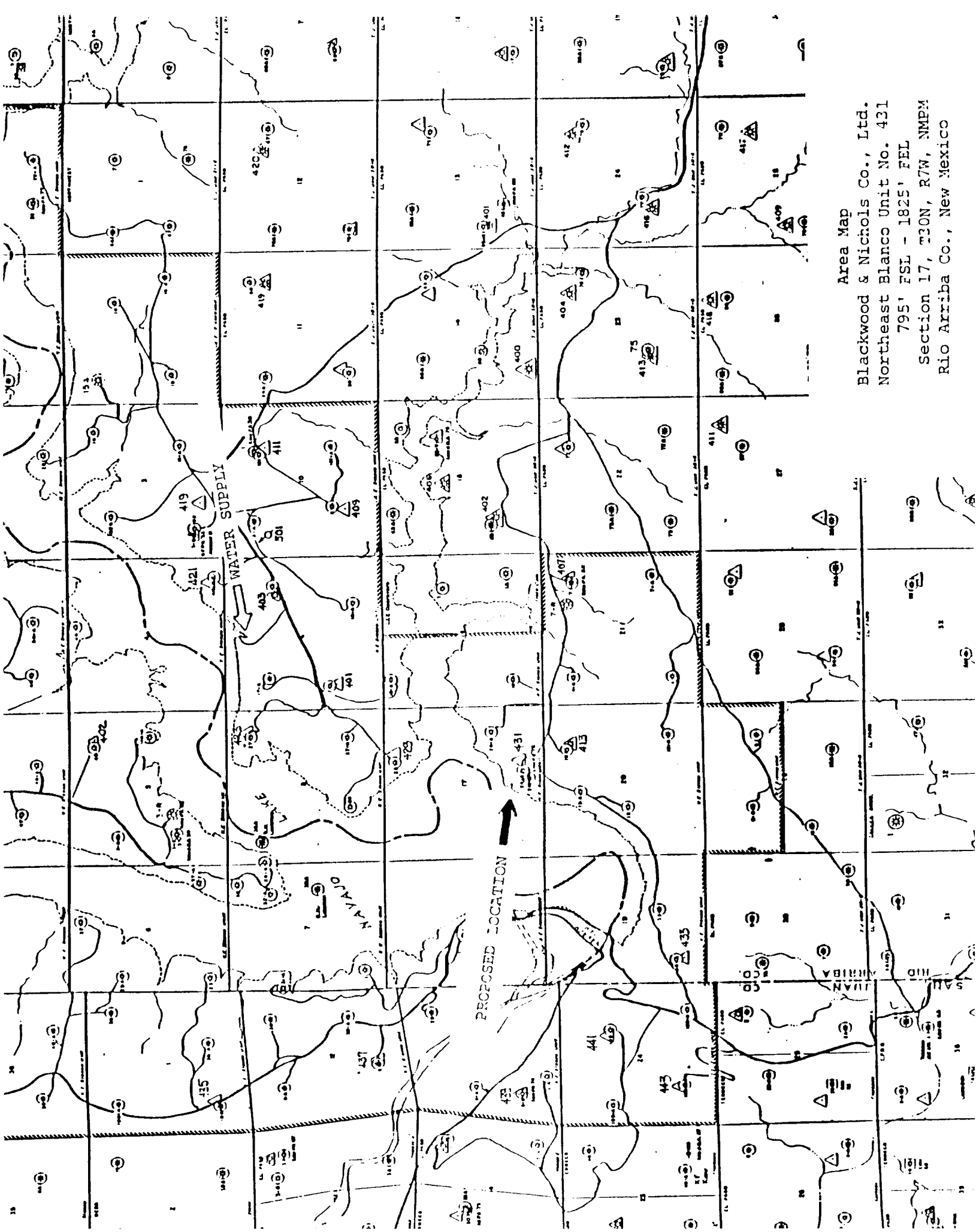
