It is intended to install a jet pump in the subject well in the following manner:

ND WH. NU BOP. TOOH with 2 3/8" tubing and clean out. TIH with a hydraulic jet pump on 2 7/8" tubing landed with pump cavity tool approximately 4' to 6' off bottom. TIH inside of 2 7/8" tubing with 1 1/4" pump string. ND BOP. NU WH. Release rig and return well to production.
