Pressure test BOP, isolation tool, manifold & lines. GIH w/ 2-7/8" tbg to get RBP. COOH w/tbg & TBP. Frac Fruitland Coal Intervals 3068-3199' down 9-3/8" casing w/575 bbls (30#/1000 gal) gelled fluid, 1,350,000 scf N₂ @ 70% quality, 168,000 lb 16/30 Brady Sand, ramped from 1 to 7 ppg. Flushed w/185 gelled water, well screened out w/6.5 ppg on formation. Max pressure 4000# psi, avg. psi 3600#, avg rat 75 bpm. ISIP-3680 psi. Immediate flow back for forced closure. Flowed back well.
