RU Western & cement w/500 SX 65/35 Poz cement w/12% gel & 1/4# gelflake per sk followed by 100 SX C1 B cement w/1/4# gelflake/sk followed by 50 SX C1 B cement. Circ. 45 SX cement. Plug down @ 8:30 AM 6-11-90. Bumped plug w/2000 psi. Held. ND BOP. Set csg slips w/75,000#. RD & released rig @ 11:00 AM.
