Devon Energy proposes to clean out and remove 5 1/2" liner. Pressure test 7" casing to 500 psi. Under-ream open hole. Re-cavitate open hole and remove near well bore coal material. Re-install 5 1/2" liner. Use a daylight workover rig (open hole) package (rig time estimate: 22 days) and surge well during the night.
