4/8/99 MIRU Key Energy #18. ND WH & NU BOPs. PT - OK. Pull Donut & BP Valve. COOH w/2-3/8" tubing. RU 3-1/2" & 2-7/8" equipment. PT -OK. GIH w/6-1/4" bit to 3520'. CO fill to TD @ 3649'. COOH. RIH w/9-1/2" underreamer. Underreamed 6-1/4" hole to 9-1/2" hole from 3524' to 3649'. CO to TD. Surged well with air & foamer & water sweeps for approx.20 days cleaning out to TD while rotating and reciprocating. COOH. RIH w/2-3/8" 4.7# tubing and set @ 3618'. RD & release rig 5/8/99.

Since this well was never connected to a pipeline, plans are to lay a temporary surface flow line to a WFS connect and set a compressor on location in an attempt to make this a productive well before any permanent flowlines are laid. (A NOI will be submitted for the temporary flow line).
