Cemented casing w/150 sx Class "B" w/2% CaCl₂ + 1/4#/sx cello-seal. Disp w/21 bbls water. Bumped plug w/800 psi. Had 4 bbl cement to surface. Float did not hold-shut in at plug container. (cemented at 1615 hrs on 10-4-93.) WOC while holding plug in place 4 hrs. NU & tested BOPs.
