Mix & Pump 500 sx Pacesetter lite w/12% gel 1/4#/sk celloseal & 2% CaCl₂-12.2 ppg slurry (191 bbls). Followed w/150 sx Class "B" net w 1/4#/sk cello-seal 15.6 ppg slurry (31.5 bbl). Displaced w/138 bbls water. Bumped plug w/2000 psi. 73 bbl lead cement to surface. (cemented at 0700 hrs on 10-12-93.) NU BOPs & set slips. RD & released rig waiting on completion rig.

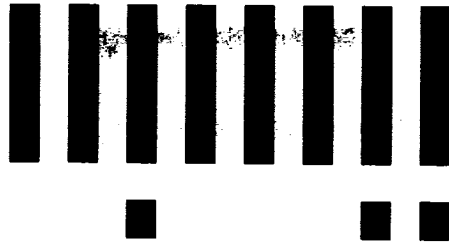
