Pump 10 bbl wtr, 10 bbl calcium chloride wtr, 7 bbl wtr, 20 bbl super flush, 7 bbl wtr ahead. Cmt'd w/306 sx Class "B" neat cmt w/3% Econolite, 0.5 pps Flocele, 10 pps Gilsonite (881 cu.ft.). Tailed w/90 sx Class "B" 50/50 poz w/2% calcium chloride (111 cu.ft.). Displace w/152.8 bbl wtr. Circ 47 bbl pre-flush to surface. WOC. PT csg to 1500 psi/15 min, OK. Drilling ahead.
