9-17-97 NU BOP. PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.

9-19-97 Drill to intermediate TD @ 3430'. Circ hole clean. TOOH. TIH w/83 jts 7" 20# J-55 LT&C csg, set @ 3420'. Cmted first stage w/196 sx Class "G" 50/50 poz w/1% calcium chloride, 10 pps Gilsonite, 0.25 pps Flocele (225 cu.ft.). Stage tool set @ 2960'.
