Displaced casing w/122 bbls FC inhibited water CRW-37 Baker Tretolite Corrosion inhibitor/packer fluid. RU Blue Jet & GIH w/7" CIBP & set @ 2900'. RD/Blue Jet. RIH w/1 jt 2-3/8" tubing and tubing hanger. PT casing, CIBP & WH to 500 psi for 30 minutes. Good test. ND BOP & NU WH. RD & released rig 10/14/00.

Phillips plans on keeping this well temporarily abandoned until it can be determined if this well can be used for recompleation into another zone sometime in the near future.
