GIH w/6-1/4" bit & tagged cement, drilled through cement & new formation from 2990' to 3146' (TD). TD reached 3/13/99. COOH. RIH w/underreamer. Underreamed 6-1/4" hole to 9-1/2" hole from 2980' to 3146'. Circulated hole. COOH. Rotated and reciprocated with air & water sweeps, then naturally surged well for approx. 17 days cleaning out to TD. GIH w/5-1/2" 15.5# J-55 casing (liner) and set @ 3141'. Top of liner set @ 3919'. Total 222' of liner.

RU Blue Jet & perf'd .75" holes 120 degree phasing @ 4 spf as follows:

3106' - 3136' total 30 feet = 120 holes

RD Blue Jet. RIH w/2-3/8" 4.7# J-55 tubing and set @ 3106' with "F" nipple set @ 3075'. ND BOPs and WH. PT - OK. Pumped off check. RD & released rig 3/31/99. Turned well over to production department.
