9/13/01 MIRU. ND wellhead, NU BOP. TOH laying down 218 jts 2-3/8" tubing.
9/14/01 RIH and set RBP at 4543'. Run GR/CCL across PC. ND BOP, NU frac valve. RDMO.
9/27/01 MIRU. ND frac valve, NU BOP. TIH with 4-1/2" RTTS packer, set at 4522'. Tested RBP to 3500 psi.
TOH. TIH with 6-1/4" bit, set 14 points on top of liner. Pump into leak at 1-1/2 BPM.
9/28/01 TOH. TIH with 7" RTTS packer, set at 3869'. Test top of liner to 3500 psi - OK. Test back side would not test, found stage tool leaking. Squeeze stage tool at 3786' with 50 sks cement.
9/29/01 TOH with packer. TIH with 6-1/8" bit, tag cement at 3738'. Drill out cement to 3786'. Pressure test squeeze to 2900 psi - OK.
9/30/01 Perforated Pictured Cliffs from 4156'-4432' total 36 holes. ND BOP, NU frac valve.
10/1/01 RU Halliburton. Frac PC with 26,396 gals 70 Q 30# linear foam and 117,111# 20/40 sand. RD Halliburton.
10/2/01 Flow back on 1/4" choke.
10/3/01 ND frac valve, NU BOP. TIH with RBP retrieving tool, tag sand at 4432'. Clean out sand to RBP at 4543', latch onto RBP.
10/4/01 TOH with RBP. TIH with 2-3/8" tubing, land at 6769', SN at 6736'. ND BOP, NU wellhead. RDMO.
This well was downhole commingled with Mesaverde by NMOC Administrative Order DHC-2935.
